4. Reports

- a. Treasurer:

- c. Groomer Update:
 - i. Groomer remains at Lulich's waiting for the front axle to be repaired. When repairs have been completed, brusher and tires will go on.
 - ii. Brushing will begin when/where able. There is a lot of brushing to do with the extensive trail system the club manages. Club members interested in brushing: Bill, Ron, Tom, Mark, Paul, Mike B. Club members can get brushing labor time reimbursed to the Alliance as long as they keep track of their hours and what equipment they use. (at a future meeting, the club may need to address compensation for fuel and wear/tear if member use their own 4-wheelers/UTVs and saws while brushing).
 - 1. Club members need to communicate with landowners if brushing on private property. The trail has a fifteen foot right away. There are many leaning trees that will need to be cleared before next winter.

iii. Signage

- 1. A suggestion was made to help preserve signs by adding an older/damaged sign perpendicularly to the top of new signs, to prevent birds from picking the stickers off.
- 2. In an article in the Bottom Line News, Recreational officer Jeff Kistner mentioned that stop signs may not be required on certain driveways (unless the property owner requests one). Yield signs could be used instead. As a safety concern, the club may still continue with stops. To be decided in the future.

5. Old Business

- a. Radio antenna
 - i. Mike Harvey obtained a quote from DSC Communications in Duluth for a new antenna for \$115.00.
